- 2. The Company has maintained the requisite registers/records and made entries therein within the time prescribed therefor;
- 3. Filing of forms and returns are not stated in the annual return, however, the Company has filed the forms and returns with the Registrar of Companies and Central Government within the prescribed time, wherever required. The Company was not required to file forms or returns with Regional Director, Tribunal, Court or other authorities;
- 4. The Company called, convened and held meetings of Board of Directors, its committees and the meeting of the members of the Company on due dates as stated in the annual return in respect of which meetings, proper notices were given and the proceedings including a circular resolution and resolutions passed by postal ballot have been properly recorded in the Minutes Book maintained for the purpose and the same have been signed;
- 5. The Company closed the Register of Members in accordance with the provisions of the Act;
- 6. The Company did not make any advances or give loans to its directors and/or persons or firms or companies referred in section 185 of the Act;



- 7. The related party transactions, as specified in section 188 of the Act, entered into by the Company during the year under review were in the ordinary course of business and at arm's length basis;
- 8. The Company did not issue, allot, buy back or approve transfer or transmission of any securities. The Company has not issued preference shares or debentures and therefore the provisions related to their redemption did not apply. The Company did not alter or reduce its share capital or convert its shares. Therefore, the provisions related to issue of security certificates in all these instances did not apply to the Company;
- 9. The provisions related to keeping in abeyance the rights to dividend, rights shares and bonus shares pending registration of transfer of shares did not apply to the Company;
- 10. Declaration and payment of dividend. The provisions related to transfer of unpaid / unclaimed dividend/other amounts to the Investor Education and Protection Fund in accordance with section 125 of the Act did not apply to the Company;
- 11. The Company complied with the provisions of Section 134 of the Act with respect to signing of audited financial statements and the report of directors as per sub-sections (3) and (5) thereof;
- 12. The Company has complied with the provisions of the Act with regard to the constitution, appointment, retirement, re-appointment, disclosures of the Directors, Key Managerial Personnel and the remuneration paid to them. The provisions related to filling up of casual vacancies of the Directors, Key Managerial Personnel did not apply to the Company;
- 13. The Company has complied with the provisions of the Act with regard to the appointment of auditors as per the provisions of section 139 of the Act: The Company had appointed S R B C & Co. LLP (ICAI registration no. 324982E/E300003) as the Auditors in the Eighteenth Annual General Meeting held on 28<sup>th</sup> July, 2017, commencing from the conclusion of that Annual General Meeting up to the conclusion of the Twenty-third Annual General Meeting held in the year 2022. The Company re-appointed S R B C & Co. LLP (ICAI registration no. 324982E/E300003) as the Auditors for the second term of five consecutive years, in the Twenty-third Annual General Meeting held on 24 August, 2022 commencing from the conclusion of that Annual General Meeting up to the conclusion of the Twenty-eighth Annual General Meeting held in the year 2027. The provisions related to filling up of casual vacancy of auditors did not apply to the Company;



- 14. The provisions related to approvals required to be taken from the Central Government, Tribunal, Regional Director, Registrar, Court or such other authorities under the various provisions of the Act did not apply to the Company;
- 15. The Company neither accepted or renewed any deposits nor was it required to repay any deposits.
- 16. Borrowings from banks. The provisions related to creation or modification of charge with respect to borrowings from banks did not apply to the Company. The Company complied with the provision with respect to satisfaction of charge. The Company did not borrow from its directors, members, public financial institutions.
- 17. Investments in other bodies corporate. The Company did not make any loans or give guarantees or provide securities to other bodies corporate or persons falling under the provisions of Section 186 of the Act during the period under review;
- 18. The Company altered the provisions of Memorandum of Association by inserting paragraphs 7A, 7B and 46A in the objects clause and altering some of the clauses of the Articles of Association of the Company, in accordance with the provisions of the Act.
