Dear Sir / Madam,

This is in reference to our earlier communication dated 10th October, 2024 (copy enclosed for reference), regarding approval of capital expenditure for setting up of a greenfield manufacturing plant at Aurangabad Industrial City ("AURIC") Bidkin, Dist. Chh. Sambhajinagar. In continuation thereto, we would like to update that the said manufacturing facility has commenced commercial production of alloy wheels for two wheelers effective from today i.e. 11th October, 2025.

The installed capacity of the plant is to manufacture 150,000 sets of alloy wheels per month, as compared to the envisaged capacity of 180,000 sets per month, announced vide our aforesaid communication dated 10th October, 2024. The plant has been strategically designed to support future capacity expansion by installing balancing equipment. This expansion will be initiated when the Company secures further orders from its OEM customers.

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13th July, 2023 ("SEBI Circular"), we wish to inform that capital expenditure for a greenfield project has been approved and that the Company plans to set up a new facility to manufacture alloy wheels for two wheelers on a land parcel of ~30 acre situated at Aurangabad Industrial City ("AURIC"), Bidkin, Dist. Chh. Sambhajinagar.

Details as per SEBI Circular are given in the table below:

1.	Existing capacity	The Company plans to set up a greenfield project at Aurangabad Industrial City (AURIC).
		The manufacturing facility shall produce alloy wheels for two wheelers.
		The Company currently manufactures alloy wheels at its plant in Chakan, Dist. Pune, where the capacity stands at 230,000 sets per month.
2.	Existing capacity utilization	Not applicable, as the proposed plant at AURIC will be a new manufacturing facility of the Company.
3.	Proposed capacity installation	180,000 sets of two-wheeler alloy wheels per month.
4.	Period within which the proposed capacity is to be added	The start of production is envisaged in Q2 of financial year 2025-26.





Sr.	Particulars	Description
5.	Investment required	The Company is in the process of completing acquisition formalities for leasehold land of ~30 acre offered by competent authority in AURIC, Bidkin, Dist. Chh. Sambhajinagar. Around 50% of the land would be put to use immediately for this proposed greenfield project and the balance land is earmarked for future projects / expansion.
		Planned capex for this facility, including the aforesaid land, is Rs. ~3,000 million (net of GST credit).
6.	Rationale	Alloy wheels add the advantage of higher fuel efficiency, better heat dissipation, enhanced vehicle performance and aesthetics in two wheelers. This, along with import substitution and higher two wheeler production by OEMs, is accelerating the demand for domestic alloy wheels.
		The Company currently manufactures and sells alloy wheels from its facility in Chakan, Dist. Pune, with consistently strong performance on quality, cost and delivery parameters. Considering peak capacity utilization at the existing plant and high inflow of new orders, setting up of this new facility is necessary.
		The new project is designed for excellence in operational and financial parameters, by deploying the best in class processes.
