- 1. I Sarika Kulkarni, Proprietor of Sarika Kulkarni & Associates, Company Secretaries, Chh. In terms of Regulation 47 of the Listing Regulations and pursuant to Rules 20 & 22 of the Rules, the Company had published an advertisement intimating about the voting on the business set out in the Notice of Postal Ballot through electronic means and dispatch of the said Notice, in an English language in Newspaper viz. 'Financial Express' and in the Marathi language in Newspaper viz. 'Loksatta,' both dated 12th September 2025 and having circulation in Chh. Sambhaji Nagar.
- 4. In compliance with Regulation 44 of the Listing Regulations and pursuant to Sections 108 and 110 of the Act read with Rules 20 and 22 of the Rules, the Company had provided Remote E-voting facility to cast votes on the resolution through the electronic voting platform of National Securities Depositories Limited ("NSDL").
- 5. Members were required to communicate their assent or dissent only through the Remote E-voting system as the hard copy of Notice of Postal Ballot along with Postal Ballot Form and pre-paid business reply envelope were not sent to the Members for this Postal Ballot pursuant to MCA Circulars.

- 6. The Remote E-voting period commenced at 09.00 am (IST) on Monday, 15th September 2025 and concluded at 05.00 pm (IST) on Tuesday, 14th October 2025 at the e-voting platform on the designated website of NSDL i.e. www.evoting.nsdl.com. E-voting facility was blocked immediately thereafter.
- 7. I monitored the process of Remote E-voting through the scrutinizer's secured link provided by NSDL through its designated website.
- 8. After completion of Remote E-voting, votes cast by the Members were unblocked by me in the presence of two witnesses, Mr. Abhijit Kulkarni and Mrs. Mohini Joshi who are not in the employment of the Company.
